

Important Safety Information

This product, general model no. QUAD4X-US, is CE certified. Keep the product a safe distance from open flame sources. Do not submerge or otherwise splash or drip liquids on the product. Dispose of depleted batteries properly.



Inserting Batteries

Remove the door on the rear of the unit and insert two (2) AAA batteries as indicated. Please note that the batteries fit snugly in the battery holder and may need to be nudged to ensure that both ends are fully touching the metal contacts.

Setting the Time

- 1) Set the inner **Mode Dial** to "Time".
The display indicates the time.
- 2) Press and hold the **Start | Pause** button for two (2) seconds.
The display flashes 12 Hr.
- 3) If desired, turn the dimpled outer collar to toggle the clock format between 12-hour and 24-hour.
- 4) Press **Start | Pause** again, once quickly, to confirm your choice.
The display now flashes the time.
- 5) Turn the collar to enter the correct time. Be careful not to move the inner **Mode Dial** accidentally.
- 6) To complete setup, press **Start | Pause**, once quickly.
The display stops flashing. Please note: Setup will also exit automatically after a short period of inactivity.

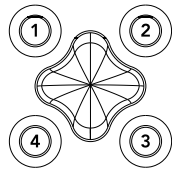

Burner Indicators

The four (4) lamps correspond to the four numbered timers. Lamps glow green for running timers and flash red when expired.

Mode Dial (Inner)

Off: Turn LCD off.

Time: Display time of day.

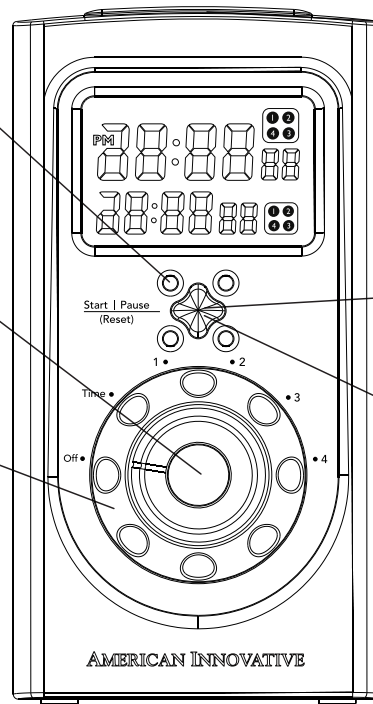
1-4: Select the active (adjustable) timer. The active timer is always visible in the Main Display (the upper one).

Value-Entry Collar (+/-)

Turn the dimpled collar clockwise to increment the active timer, counter-clockwise to decrement. Timer values change by one minute (up to 30 minutes), by five minutes (from 30 minutes to 2 hours) and by 15 minutes after that. Timers may also be adjusted while running.

Note

To adjust a timer visible in the Sub-Display, first make it active in the Main Display using the inner **Mode Dial**.



Mute | Toggle (top of unit)

Mute: Press to silence expired timers. Expired timers count up from 0:00:00 until silenced.

Toggle: If no timer is sounding, use this button to select which timer is visible in the Sub-Display. Note: For convenience, the first running timer is automatically placed in the Sub-Display once a second timer is set.

Start | Pause (Reset)

Start | Pause: The active timer (the one visible in the upper display) may be started or stopped using this button.

Reset: Press and hold this button for two (2) seconds to reset the active timer.

Batch Feature

Batch: If the active timer is expired (0:00:00), press this button to recall the last value entered. This function is convenient for repeatedly timing batches of cookies, for example.
